Hon. Treasurer's Report for Financial Year ending 30 September 2024

Dawn Holley introduced the audited accounts.

Dawn explained that Welsh Athletics have increased both the WA component of the membership fee together with a significant increase in the club's affiliation fee to the governing body. The fee has changed from a flat rate amount to one directly linked to the number of members (a pound levy for each club member). Given that Swansea continues to have the highest number of members across Welsh clubs, this change has a particular impact on us.

The Financial Report was unanimously approved with Ian Griffiths proposing and Neal Merry seconding the report.
